

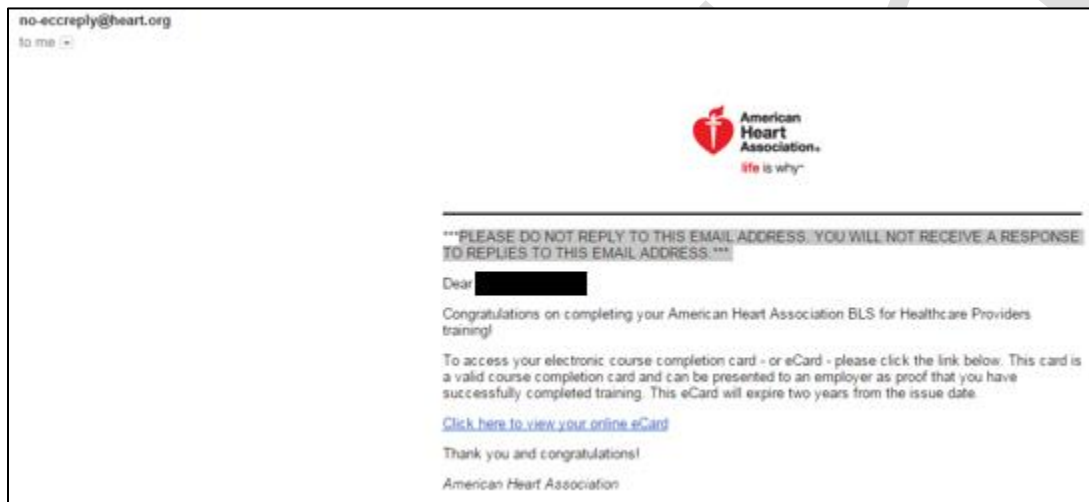
AHA Course Completion eCard Instructions

The email will have a link for you to follow to accept your eCard.

It is extremely important that you accept your eCard as soon as you are able to after receiving your email notification.

- Until you have accepted your eCard, your employer will not have access to validate your certification.
- If your employer requires proof of your certification, claim your card immediately and forward your eCard ID or printed certificate to your manager or HR department.
Failure to do so may result in not being allowed to work.
- **Centura employees: Upon accepting your eCard, provide your manager with your eCard ID.**


