RENTAL TERMS AND CONDITIONS

RENTER hereby agrees as follows:

1. RENTER shall keep the Equipment in a good state of repair, normal wear and tear excepted, and is responsible for any damage to, loss or theft of the Equipment occurred during the Rental Period.
2. RENTER shall pay EdCor LLC full compensation for replacement and/or repair of any Equipment that may be damaged, lost or stolen during the Rental Period. EdCor 's invoice for replacement or repair costs is conclusive as to the amount RENTER shall pay under this paragraph for repair or replacement.
3. RENTER shall not remove the Equipment from the address of RENTER or the location shown herein as the place of use of the equipment without prior written approval of EdCor,LLC
4. The equipment shall be picked up by RENTER and returned to EdCor at the RENTER's risk, cost and expense.
5. No allowance will be made for any rented Equipment or portion thereof which is claimed not to have been used. Acceptance of returned Equipment by EdCor does not constitute a waiver of any of the rights EdCor has under the rental agreement.
6. RENTER agrees to pay the replacement cost for any equipment that is not returned, returned in a nonoperational status or returned with wear and tear beyond standard use.
7. EdCor makes no warranty of any kind regarding the rented Equipment, except that EdCor may replace the Equipment with identical or similar Equipment if the Equipment fails to operate in accordance with the manufacturer's specifications and operation instructions but only if EdCor has available Equipment in its possession. Such replacement shall be made as soon as practicable after RENTER returns the non conforming Equipment.
8. RENTER indemnifies and holds EdCor harmless for any and all injuries or damage due to the use of Equipment and for all consequential and special damages for any claimed breach of warranty.
9. RENTER shall pay all reasonable attorney and other fees, the expenses and costs incurred by EdCor in protection of its rights under this rental agreement and for any action taken by EdCor to collect any amounts due to EdCor under this rental agreement.
10. These terms are accepted by RENTER upon delivery of the terms to the RENTER or the agent or other representative of RENTER.
11. Equipment is rented for a 48 hour period (business days). Additional time can be approved by Edcor upon request if the equipment will not be needed for other classes. If the equipment is returned later than 24 hours after the agreeded upon return day an additional rental charge will be applied. The new charge will generate a new 48 hour period with the same late penalty applying.
